

## Memorandum of Understanding (MoU)

University of Calcutta  
Address: 92, APC Road, Kolkata - 700 009, India  
Represented by Prof. Ashutosh Ghosh, Vice Chancellor

and

University of Silesia in Katowice  
Address: 12 Bankowa Street, 40-007 Katowice, Poland  
Represented by Prof. Tomasz Pietrzykowski, Vice-Rector for Domestic and International Cooperation,

hereinafter referred to as the "Parties",

in order to enhance educational and research cooperation shall enter into the following agreement:

### **Article 1:**

The two aforesaid Parties wish to establish cooperation in the areas of mutual interest, namely: education, research, administrative management.

### **Article 2:**

The purpose of this MoU can include, but is not limited to the following activities:

- Exchange of research and teaching personnel,
- Exchange of students,
- Academic and research programs,
- Double diploma programs,
- Co-tutelle (joint Ph.D.) program,
- Guest lectures, seminars, symposia, study visits, consultations and other forms of cooperation of mutual character,
- All administrative management tasks of mutual interest.

### **Article 3:**

Each party appoints a Coordinator the activities undertaken under this MoU.

Coordinator for the University of Calcutta is:  
Vice Chancellor, Prof. Ashutosh Ghosh.

Coordinator for the University of Silesia in Katowice is:  
Prof. Tomasz Pietrzykowski Vice-Rector for Domestic and International Cooperation.

**Article 4:**

Any specific activity shall be the subject of mutual consent and approval of both Universities. The detailed terms of such activity shall be discussed and agreed upon in writing, by the two aforesaid Coordinators of both Universities prior to the initiation of any particular program of activity, with reference to this MoU.

**Article 5:**

The MoU is concluded for an initial duration of five years and can be extended by written annex signed by both Parties. All changes hereto must be made in writing in the form of an annex and shall be binding when signed by both Parties. Each Party may terminate the MoU with six months written notice counted from the date of notification of the other Party. In that case, the actions in hand shall be brought to completion.

**Article 6:**

The Parties agree to place information about the agreement on their website and in promotional materials along with the permission to use the logo of the Partner.


**Article 7:**
